- (a) the details of the programmes being implemented for the development of rural infrastructure in the country;
- (b) the details of the assistance provided for the development of rural infrastructure through Rural Infrastructure Development Fund (RIDF) during the last four years, State-wise; and
- (c) the details of the rural developmental works completed in West Bengal, Bihar including Sitamarhi and Haryana including Sonipat district using RIDF during the last four years and the current financial year, year-wise and district-wise?

- (a) to (c): A statement is laid on the Table of the House.

Statement referred in reply to parts (a) to (c) of Lok Sabha Starred Question No. *176 to be answered on 13.03.2023 regarding Assistance under RIDF by Ms. Locket Chatterjee and Shri Sunil Kumar Pintu:

(a): The Ministry of Rural Development (MoRD) is implementing a number of welfare schemes in rural areas for bringing an overall improvement in the quality of life of the people, strengthening livelihood opportunities, promoting self-employment, development of infrastructure etc. These include Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS), Pradhan Mantri Awaas Yojana – Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhyay – Gramin Kaushalya Yojana (DDU-GKY) etc.

In addition, National Bank for Agriculture and Rural Development (NABARD) is implementing various schemes for development of critical infrastructure in rural areas under various funds, such as, Rural Infrastructure Development Fund (RIDF), Long Term Irrigation Fund (LTIF), Micro Irrigation Fund (MIF), Dairy processing and Infrastructure Fund (DIDF), Fisheries and Aquaculture Infrastructure Fund (FIDF).

(b): The details of the assistance provided for the development of rural infrastructure through Rural Infrastructure Development Fund (RIDF) during the last four years, State-wise are furnished in *Annexure I*.

(c): The details of the rural developmental works completed in West Bengal, Bihar including Sitamarhi and Haryana including Sonapat district using RIDF during the last four years and the current financial year, year-wise and district-wise are furnished in *Annexure II, Annexure III and Annexure IV* respectively.
