## IMPLEMENTATION OF PMFME SCHEME

## \*295.SHRI RAJVEER SINGH (RAJU BHAIYA): SHRI VINOD KUMAR SONKAR:

Will the MINISTER OF *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether the Food Processing Sector is a rising segment/sector in the country and has created history in agriculture and processed food exports by exporting products worth US\$25.6 billion in Financial Year 2022 and if so, the details thereof;
- (b) whether the Government is successfully implementing Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) Scheme in the country;
- (c) If so, the details thereof along with the achievements made since its inception;
- (d) the number of individual beneficiaries, Farmer Producer Organizations (FPOs), Self Help Groups (SHGs) and producer cooperatives that have been benefited under PMFME Scheme since its launch, State-wise;
- (e) the percentage of beneficiaries in the rural and urban areas out of those who have availed the Scheme; and
- (f) the number of skill training workshops/sessions which have been conducted under the Scheme till date?

## **ANSWER**

STATEMENT REFERRED TO IN REPLY TO PART (a) TO (f) OF LOK SABHA STARRED QUESTION NO. \*295 ANSWERED ON 21.03.2023 REGARDING "IMPLEMENTATION OF PMFME SCHEME"

- (a). As per the Directorate General of Commercial Intelligence and Statistics (DGCIS), the total agriexports for 2021-22 was USD 46.1 Billion out of which USD 10.4 Billion was of processed food products.
- (b) to (e). Yes, Sir. Till date, 25,774 loans have been sanctioned under credit linked subsidy component of PMFME Scheme to individual beneficiaries, Farmer Producer Organizations (FPOs), Self Help Groups (SHGs) and producer cooperatives. In addition, seed capital has been released for 92,108 rural SHG members (81.82%) and 20,462 urban SHG members (18.17%). The State-wise details are at **Annexure**.
- (f). Under the Capacity Building component of PMFME Scheme, 25 training workshops/sessions have been conducted for 486 Master Trainers, 76 sessions for 983 District Level Trainers, 54 sessions for 1286 District Resource Persons and 1085 sessions for 27,949 beneficiaries have been conducted till date.
