Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the Command Area Development and Water Management Programme (CADWM) is being implemented in the country particularly in Parbhani Parliamentary Constituency of Maharashtra;
- (b) if so, the current status thereof;
- (c) the details of the funds allocated and utilized along with the number of beneficiaries under the said programme during the last five years, State/UT and year-wise;
- (d) the details of the works done under the said programme in other districts, tehsils and towns of Maharashtra during the last five years; and
- (e) the steps being taken/proposed to be taken by the Government to expedite and expand the works under the said programme?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF STARRED QUESTION NO. *332 TO BE ANSWERED IN LOK SABHA ON 23.03.2023 REGARDING “CADWM”.

(a) Yes, Sir. The Command Area Development and Water Management programme (CADWM) is being implemented in the country, including in parts of Parbhani Parliamentary Constituency of Maharashtra.

(b) Presently, the CADWM Programme is being implemented pari passu with the prioritized projects of Pradhan Mantri Krishi Sinchayee Yojana - Accelerated Irrigation Benefits Programme (PMKSY-AIBP) under the PMKSY component of Har Khet Ko Pani (HKKP) from 2015-16 onwards. Culturable Command Area (CCA) of 45.08 lakh hectares has been targeted under PMKSY-CADWM programme.

There are 22 PMKSY-CADWM projects in Maharashtra. Lower Dudhna CADWM project benefits the Parbhani Parliamentary Constituency of Maharashtra. It has been included under CADWM programme with following features:

Target CCA	30,000 ha
Total cost	Rs.145 crore
Central Assistance (CA) component	Rs.72 crore
CA Release (From 2016-17 to 2021-22)	Rs 20 crore
Physical progress in CCA till March 2022	20,500 ha

(c) Under the PMKSY-CADWM, the year wise details of CA released and expenditure incurred for the various State/UTs is provided at **Annexure-I**. Data on beneficiaries is not maintained in the Ministry.

(d) For the 22 projects of Maharashtra under PMKSY-CADWM, the details of district/tehsils/towns benefitted as well as physical and financial targets/progress projects of Maharashtra are given in the **Annexure-II**.

(e) To expedite and expand the works under CADWM Programme, project monitoring is done regularly. This includes-

1. The assessment of progress done through monitoring visits undertaken by CWC field offices (CAD Cells) and by Project Monitoring Unit (PMU) established in the Ministry in respect of PMKSY;
2. Monitoring the progress of projects through online CADWM-Information System portal;
3. Reviewing the implementation of projects through ‘Project Implementation Review Committee (PIRC)’ meetings held periodically; and
4. Reviews of program implementation undertaken in Ministry of Jal Shakti.
