- (a) the details of the status of implementation of Jal Shakti Abhiyan and Atal Bhujal Yojana in the States of West Bengal and Uttar Pradesh; and
- (b) the details of the work completed in Malda North, Salempur and Kannauj Lok Sabha Constituencies under the said schemes/projects?

ANSWER

STATEMENT REFERRED TO IN REPLY TO PARTS (a) AND (b) OF LOK SABHA STARRED QUESTION NO. *340 FOR ANSWER ON 23.03.2023 REGARDING “JAL SHAKTI ABHIYAN”.

(a) The Jal Shakti Abhiyan (JSA) was launched in the year 2019 in 1,592 blocks out of 2,836 blocks in 256 water stressed districts of the country. “Jal Shakti Abhiyan: Catch the Rain” (JSA: CTR) in 2021 and JSA: CTR 2022 were launched with the theme “Catch the Rain – Where it Falls When it Falls” to cover all the blocks of all districts (rural as well as urban areas) across the country, including Uttar Pradesh and West Bengal during the pre-monsoon and monsoon period. Hon’ble President has now launched JSA: CTR -2023 on 04.03.2023 with the theme "Source Sustainability for Drinking Water" for implementation in all the blocks of all districts (rural as well as urban areas) across the country.

The focused interventions of the campaign include (1) water conservation and rainwater harvesting; (2) enumerating, geo-tagging & making inventory of all water bodies; preparation of scientific plans for water conservation based on it; (3) setting up of Jal Shakti Kendras in all districts; (4) intensive afforestation; and (5) awareness generation.

Atal Bhujal Yojana (ATAL JAL), a Central Sector Scheme with an outlay of Rs 6,000 crore, is for implementation in identified water stressed areas of 8,220 Gram Panchayats (GPs) under 229 blocks in 80 districts of 7 States viz. Gujarat, Haryana, Karnataka, Madhya Pradesh, Maharashtra, Rajasthan and Uttar Pradesh through active participation of the communities in these States. Various activities such as monitoring and disseminating ground water data, water budgeting, preparation of GP wise Water Security Plans (WSPs), their implementation through convergence of ongoing schemes related to sustainable groundwater management are carried out under this scheme. In Uttar Pradesh, the scheme is being implemented in 550 GPs of 26 Blocks under 10 Districts. The scheme is not being implemented in West Bengal.

(b) The details of the work completed in the districts of Malda North, Salempur and Kannauj Lok Sabha Constituencies during JSA:CTR-2021 & JSA:CTR-2022 are given at **Annexure-I & Annexure II** respectively. Atal Bhujal Yojana is not being implemented in Malda North, Salempur and Kannauj Parliamentary constituencies.
