- (a) the details of budgetary allocation under the Pradhan Mantri Khanij Kshetra Kalyan Yojana(PMKKKY), State-wise, during the last five years particularly for the State of Maharashtra:
- (b) the details of funds released and actual utilisation under the PMKKKY, Statewise, particularly for Maharashtra during the said period;
- (c) whether there has been any discrepancy between the expected standards and the actual value of allocations made during the said period; and
- (d) if so, the details of the measures being taken by the Government to address this?

STATEMENT REFERRED IN REPLY TO PARTS (a) TO (d) OF LOK SABHA STARRED QUESTION NO. 468 FOR ANSWER ON 05.04.2023 ASKED BY SHRI GIRISH BHALCHANDRA BAPAT; SHRI CHANDRA SEKHAR SAHU REGARDING PMKKKY.

(a) to (d): There is no provision for budgetary allocation from Central Government or State Governments to District Mineral Foundations / Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY). The various projects taken up under Pradhan Mantri Khanij Kshetra Kalyan Yojna (PMKKKY) are funded through the funds accrued under DMFT. DMF is funded by statutory contributions received from the holders of mining lease in terms of the fixed percentage of royalty prescribed by the Central Government.

Section 9B of the MMDR Act,1957 prescribes the establishment of District Mineral Foundation (DMF) in any district affected by mining related operations, the object of which is to work for the interest and benefit of persons, and areas affected by mining related operations in such manner as prescribed by the State Governments.

The State-wise details of funds collected and the amount allocated for projects under DMF/PMKKKY for the last five years is provided as Annexure.
