(a) the details of funds allocated under the Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) scheme in the last five years;

(b) the details of developmental and welfare projects that have been completed under the said scheme, State-wise, including the States of Uttar Pradesh, Odisha and Rajasthan; and

(c) the details of total number of beneficiaries whose long-term sustainable livelihoods have been ensured under this scheme, State-wise including, Uttar Pradesh, Odisha and Rajasthan?

(a): Ministry of Mines circulated guidelines for Pradhan Mantri Khanij Kshetra Kalyan Yojna (PMKKKY) on 16.09.2015 to be implemented by the District Mineral Foundations (DMF) for taking up development and welfare projects/programs in mining-affected areas. The fund is allocated from the District Mineral Foundation to various projects to be taken up under PMKKKY. Details of funds allocated by various DMFs to the projects taken up under PMKKKY in the last five years are as under:

(b) & (c): As per PMKKKY guidelines, at least 60% of the funds are to be spent on High Priority areas (Drinking Water, Environment Preservation and Pollution Control measures, Health Care, Education, Welfare of Women and Children, Welfare of aged and disabled, Skill Development, Sanitation) and up to 40% of the fund are to be spent on other priority activities (Physical infrastructure; Irrigation; Energy and watershed development; and Any other measures for enhancing environmental quality in mining district). Till December 2022, total 2,60,295 projects have been sanctioned under the scheme and total 1,39,912 projects have been completed so far. Details are provided as **Annexure-I**. Details of beneficiaries under the PMKKKY are maintained by the concerned districts.
