- (b) if so, the number of Livelihood Business Incubators (LBIs) that have been set up under this scheme, State-wise, including Uttar Pradesh, Rajasthan and Odisha;
- (c) whether any LBIs have been set up in Gonda-Bahraich, Deoria, Pratapgarh in Uttar Pradesh, Pali in Rajasthan and Balasore in Odisha; and
- (d) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

## MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a): A Scheme for Promotion of Innovation, Rural Industries and Entrepreneurship (ASPIRE) is continued to be functional during the Financial Year 2021-22 to 2025-26.
- (b): As on date, 81 Livelihood Business Incubators (LBIs) have been established under ASPIRE. A list of LBIs (State-wise) including Uttar Pradesh, Rajasthan and Odisha is at **Annexure-I**.
- (c) & (d): A Livelihood Business Incubator (LBI) under ASPIRE has been set up at National Small Industries Corporation (NSIC), District Deoria of Uttar Pradesh. Detail of the same are annexed at **Annexure-II**. However, due to non-receipt of any feasible proposal from the Districts of Gonda, Bahraich and Pratapgarh in Uttar Pradesh, District Pali in Rajasthan and District Balasore in Odisha, LBI under ASPIRE has not yet been set up in these Districts.
