Will the Minister of STATISTICS AND PROGRAMME IMPLEMENTATION be pleased to state:

- (a) the details and present status of ongoing infrastructure projects of national importance across the country, State-wise including Jharkhand and NCT of Delhi;**
- (b) whether some of these projects are delayed due to the involvement of various agencies such as land acquisition, forest-clearance, utility shifting, etc.;**
- (c) if so, the details thereof; and**
- (d) the steps being taken by the Government in this regard?**

ANSWER

MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF STATISTICS AND PROGRAMME IMPLEMENTATION, MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF PLANNING AND MINISTER OF STATE IN THE MINISTRY OF CORPORATE AFFAIRS [RAO INDERJIT SINGH]

(a) The Infrastructure and Project Monitoring Division (IPMD) of the Ministry of Statistics and Programme Implementation is mandated to monitor time and cost overruns of Central Sector Infrastructure Projects costing Rs. 150 crores and above, based on the information provided by the project implementing agencies on Online Computerized Monitoring System (OCMS) of this Ministry. As on 01.01.2023, 1,438 Central Sector Infrastructure projects, with anticipated completion cost of Rs.

24,86,069.52 crore, were on the Ministry's OCMS portal. The details and present status of ongoing central sector infrastructure projects are available on the website www.cspm.gov.in. The State-wise details of ongoing infrastructure projects, including Jharkhand and NCT of Delhi, can be seen at Annexure A.

(b)&(c) Yes Sir, some of these projects are delayed due to reasons such as land acquisition, forest-clearances, utility shifting etc. The State-wise details of delayed projects are at Annexure A.

(d) The steps being taken by the Government to control the delays are: Periodic review of projects under PRAGATI; rigorous project appraisal; On-line Computerized Monitoring System (OCMS) for better monitoring; setting up of Revised Cost Committees in the Ministries; regular review of infrastructure projects by the concerned administrative Ministries; and setting up of Central Sector Projects Coordination Committees (CSPCCs) in the States under the concerned Chief Secretaries for removal of bottlenecks and for facilitating the speedy implementation of major projects.
