VARIOUS SCHEMES IN MSME SECTOR

1173. SHRI DILIP GHOSH:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of various schemes launched for the progress of Micro, Small and Medium Enterprises (MSMEs) in the country, State-wise including West Bengal during the last five years;
- (b) the number of employment opportunities created by the MSMEs in the country, State-wise including West Bengal, district-wise during the said period;
- (c) whether any new scheme is proposed to be introduced in near future in MSME sector; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES

(a): Ministry of MSME through its field offices network, implements various schemes/programmes for the promotion and development of Micro, Small and Medium Enterprises (MSMEs) sector across the country including the State of West Bengal which inter alia include Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Credit Guarantee Scheme for Micro and Small Enterprises (CGTMSE), A Scheme for Promotion of Innovation, Rural Industries and Entrepreneurship (ASPIRE), Entrepreneurship and Skill Development Programme (ESDP), National Schedule Caste and Schedule Tribe Hub (NSSH) etc.

In the recent past, the Government has taken number of initiatives to support MSMEs in the country including the State of West Bengal. Some of these include:

- (i) Rs. 5 lakh crore Emergency Credit Line Guarantee Scheme for business, including MSMEs.
- (ii) Rs. 50,000 crore equity infusion through Self Reliant India Fund.
- (iii) New revised criteria for classification of MSMEs.
- (iv) No global tenders for procurement up to Rs. 200 crores.
- (v) "Udyam Registration" for MSMEs, for Ease of Doing Business.
- (vi) Launching of an online Portal "Champions" in June, 2020 to cover many aspects of e-governance including redressing grievances and handholding of MSMEs.
- (vii) Inclusion of Retail and Wholesale traders as MSMEs on 02.07.2021.
- (viii) Non-tax benefits extended for 3 years in case of an upward change in status of MSMEs.
- (ix) Roll out of Raising and Accelerating MSME Performance (RAMP) programme with an outlay of Rs. 6,000 crore over 5 years.
- (x) Launch of Udyam Assist Platform (UAP) on 11.01.2023 to bring the Informal Micro Enterprises (IMEs) under the formal ambit for availing the benefit under Priority Sector Lending (PSL).

The Ministry of MSME has launched 'MSME Innovative Scheme' and 'MSME Sustainable (ZED) Certification Scheme' on 10.03.2022 and 28.04.2022 respectively, under the 'MSME Champions' Scheme. 'MSME Innovative Scheme' is aimed at promoting innovation among MSMEs through incubation, design intervention and by protecting Intellectual Property Rights (IPR), whereas 'MSME Sustainable (ZED) Certification Scheme' is based on an assessment model which includes various parameters that encourage MSMEs to improve their processes and systems to enhance quality and also move towards sustainability.

(b): As per erstwhile 'Udyog Aadhaar Memorandum' portal (from 01.04.2017 to 30.06.2020) and new 'Udyam Registration' portal (from 01.07.2020 to 31.03.2022), the number of employment opportunities created by the MSMEs, State-wise in the country and District-wise in the State of West Bengal, are given at Annexure-I and Annexure-II, respectively.

(c) & (d): Formulation of schemes/programmes to cater to the growing needs of MSMEs in the country is an ongoing process. Ministry of MSME introduces various schemes/programmes depending upon the emerging needs of Indian MSME sector.
