(a) PM Gati Shakti National Master Plan (NMP) envisages a mechanism for coordinated planning and holistic integrated

infrastructure development in the country across all sectors through inter-connected and multimodal transportation networks economic development, improved trade competitiveness, promotion of exports and employment generation, etc. It envisages establishing integration and synergy amongst different infrastructure sector projects such as Railways, Roads, Ports, Waterways, Airports, Mass Transport, Logistics Infrastructure, supported by complementary Transmission. Energy Information **Technology** Communication, Social Infrastructure, etc., so as to facilitate coordinated and integrated planning, project preparations and implementations, optimization of logistics arrangements efficient transportation systems.

The plan has been developed as a Digital Master Planning tool by BISAG-N (Bhaskaracharya National Institute for Space Applications and Geoinformatics) and has been prepared in dynamic Geographic Information System (GIS) platform for incorporating data on specific action plan of all the Ministries/Departments within a comprehensive database.

(b) The Ministry is primarily responsible for development and maintenance of NHs. All the NHs development projects of the Ministry are planned in line with PM GatiShakti NMP Principles.

No separate funds are allocated by the Ministry for PM GatiShakti NMP. Details of funds allocated and expenditure incurred / funds released for development of NHs during the last year and the current year for the States of Assam, Rajasthan, Uttar Pradesh, Odisha and Madhya Pradesh are as under: -

(e) The Ministry closely monitors various issues that affect project, environment/forest/wildlife clearances, Road Over Bridge (ROB) & Road Under Bridge (RUB) issues, contractual issues, land acquisition, encroachment removal, law & order issues, utility shifting, etc., for all NHs projects in various States including in the States of Assam, Rajasthan, Uttar Pradesh, Odisha and Madhya Pradesh. Progress of projects is monitored through advanced digital platforms such as Project Monitoring Information System (PMIS) and Data Lake, BhoomiRashi portal (for Land Acquisition). Periodic reviews are held at various levels in the Ministry with all stakeholders including officers of executing agencies (such as National Highways Authority of India (NHAI), National Highways & Infrastructure Development Corporation Ltd. (NHIDCL), Border Roads Organization (BRO), State Governments and Union Territories (UTs)) to resolve these issues and ensure timely implementation of projects.
