Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of the States that have hundred per cent coverage under Jal Jeevan Mission (JJM) Har Ghar Jal Yojana;
- (b) the details of the households that have been covered by the Ministry under JJM-Har Ghar Jal Yojana in Telangana;
- (c) the funds spent under JJM-Har Ghar Jal Yojana in Telangana;
- (d) whether it is true that there are many States which have not been covered even sixty per cent under the yojana; and
- (e) if so, the efforts being made by the Ministry to cover all households in such States and the time by which the Ministry is likely to cover such States?

ANSWER

MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal to make provision of tap water supply to every rural household by 2024.

As on 07.02.2023, as reported by States/UTs, the States of Goa, Haryana, Gujarat, and Telangana, and UTs of Andaman & Nicobar Islands, Dadra & Nagar Haveli and Daman & Diu, and Puducherry have reported hundred percent coverage of rural households with potable tap water supply out of which States of Goa and Haryana and UTs of A & N Islands, Puducherry and D&NH and D&D are 'Har Ghar Jal' Certified States/ UTs.

(b) As reported by Govt. of Telangana, at the time of launch of Jal Jeevan Mission in August, 2019, out of 53.98 lakh rural households, 15.68 lakh households (29.05%) had tap water connections. Thereafter, remaining 38.30 lakh households (70.95%) have been provided with tap water connections.

(c) The details of funds spent under JJM in Telangana since FY 2019-20 are as under:

(d) At the time of announcement of Jal Jeevan Mission, out of 18.93 Crore rural households, 3.23 Crore (17%) households were reported to have tap water connections. Since then, tap water connections have been provided to additional 7.87 Crore rural households. Thus, as reported by States/UTs, as on 07.02.2023, out of 19.39 Crore rural households in the country, provision of tap water supply has been made to 11.10 Crore (57.28%) households. (e) Drinking Water is a State subject and accordingly the responsibility to plan, design, approve and implement drinking water supply schemes lies with States. Government of India supplements the efforts of the States by providing technical and financial assistance.

However, number of steps have been taken to plan and implement JJM in the whole country with speed, inter alia, which includes joint discussion and finalization of annual action plan (AAP) of States/ UTs, regular review of implementation, workshops/ conferences/ webinars for capacity building and knowledge sharing, field visits by multi-disciplinary team to provide technical support, etc. A detailed Operational Guideline for the implementation of JJM; Margdarshika for Gram Panchayats & VWSCs to provide safe drinking water in rural households and Guidelines on a special campaign to provide piped water supply in anganwadi centres, ashramshalas and schools have been shared with States/ UTs, to facilitate planning and implementation of Jal Jeevan Mission. For online monitoring, JJM—Integrated Management Information System (IMIS) and JJM—Dashboard has been put in place. Provision has also been made for transparent online financial management through Public Financial Management System (PFMS).
