# LOK SABHA UNSTARRED QUESTION NO. 1239 TO BE ANSWERED ON FEBRUARY 09, 2023

#### INTELLIGENT TRAFFIC MANAGEMENT SYSTEM

#### NO. 1239. SHRI HIBI EDEN:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Intelligent Traffic Management System (ITMS), to streamline traffic movement and help enforce traffic rules in the Greater Kochi area, is fully functional and if so, the details thereof;
- (b) the number of electronic monitoring devices set up in project area and the locations/roads at which such devices have been installed;
- (c) the number of such electronic monitoring devices which are nonoperational along with the reasons therefor;
- (d) whether the night-vision cameras of ITMS are ensuring rule enforcement round the clock; and
- (e) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) to (c): Cochin Smart Mission Limited (CSML) is implementing the Intelligent Traffic Management System (ITMS) project in the Kochi Municipal Corporation area under the Smart Cities Mission (SCM).

As part of the project, 32 junctions have been installed with 115 surveillance cameras, out of which 39 cameras are Pan Tilt Zoom (PTZ) type, 44 are fixed type and 32 cameras have Red-Light Violation Detection (RLVD) system. The locations of these cameras are given in Annexure-I

In addition to these cameras, 19 junctions are also having Adaptive Traffic Control Signals (ATCSs). Amongst these 19 signals, 8 are operating in ATCS mode and 11 are operating in Fixed Timer mode.

Kochi Smart city has informed that, currently one location at Kaloor area, having 4 camers, is not operational due to cable damage as a result of excavation for drain work.

(d) & (e): Yes, Sir. The night vision cameras of ITMS are helping law enforcement agencies through Automatic Number Plate Recognition System (ANPR) and gathering evidence for maintaining law and order.
