FUNDS UNDER PMAY-U

NO. 1251. DR. SUKANTA MAJUMDAR:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of funds released to West Bengal under the Pradhan Mantri Awas Yojana- Urban (PMAY-U) since 2019, year-wise;
- (b) the details of projects proposals received, approved and executed under the PMAY-U since 2019 in the said State, district-wise; and
- (c) the details of beneficiaries under the PMAY-U in the districts of South Dinajpur and North Dinajpur since 2019, year-wise, including the complaints received regarding corruption in allotment of houses under PMAY-U?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) & (b): The Ministry of Housing and Urban Affairs (MoHUA) is implementing Pradhan Mantri Awas Yojana - Urban (PMAY-U) since 25.06.2015 to provide pucca house with basic amenities to all eligible urban beneficiaries across the country. The scheme is implemented through four verticals i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), In-Situ Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS) based on eligibility criteria as per scheme guidelines. Under PMAY-U, as on 31.03.2022, against the validated demand of 112.24 lakh houses, 122.69 lakh houses were sanctioned, out of which more than 107.55 lakh houses have been grounded and 68.02 lakh have been completed/delivered to the beneficiaries. Since 2019, for the State of West Bengal ₹ 931.36 Cr. in FY 2019-20; ₹ 1,606.02 Cr. in FY 2020-21; ₹ 431.24 Cr. in FY 2021-22

and ₹ 1,034.72 Cr. in FY 2022-23 (till 23.01.2023) were released for construction of houses sanctioned in the state. The district wise details of houses sanctioned, grounded and completed/delivered to West Bengal is at Annexure-I.

(c): Any instance of irregularity/complaint/representation regarding PMAY-U including those of ineligible applicants during the entire course of implementation are addressed through suitable grievance redressal system available at both State/UT and City level as per existing rules and regulations. Moreover, a Centralised Public Grievance Redress and Monitoring System (CPGRAMS) is also available to the citizens to lodge their grievances to the public authorities on any subject related to service delivery including PMAY-U for redressal. Further, MoHUA has also developed a Public Grievances Redress and Monitoring System for registering any form of complaints regarding implementation of PMAY-U and its speedy disposal. The years-wise details of beneficiaries, since 2019, under the PMAY-U in the districts of South Dinajpur and North Dinajpur is at Annexure-II.
