Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of the funds allocated/released/utilised by the State of Odisha and Bihar under National Rural Drinking Water Programme (NRDWP) during the last three Years;
- (b) the number of projects completed under the Scheme in the said States particularly, in Cuttack, Nayagarh, Puri, Jagatsinghpur, Kendrapada, Bhadrak and Balasore, districts of Odisha during the said period;
- (c) the names/details of the project proposals pending under the programme in the said States, district-wise: and
- (d) the steps taken/proposed to be taken by the government for the approval and implementation of all pending proposal under the programme?

#### **ANSWER**

### MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) In August, 2019, National Rural Drinking Water Programme (NRDWP) was subsumed into Jal Jeevan Mission (JJM)—Har Ghar Jal, which aims to provide tap water connection to every rural household of the country by 2024. The details of funds allocated/released/utilised by the States of Odisha and Bihar under JJM during the last three years are as under:

As reported by State Government of Bihar, 3,140 schemes have been completed since the launch of JJM on 15.08.2019.

As reported by the State Government of Odisha, the number of projects completed under JJM in Cuttack, Nayagarh, Puri, Jagatsinghpur, Kendrapara, Bhadrak and Balasore districts is annexed.

(c) and (d) As reported by State Governments of Odisha and Bihar, none of the project proposals are pending for approval under the programme in these States.

Drinking Water being a State subject, it is States, who plan, design, approve and implement drinking water supply schemes. Government of India supplements the efforts of the States by providing technical and financial assistance.

To ensure the successful implementation, Government of India has been regularly reviewing the planning and implementation with all States/ UTs including Odisha and Bihar. Regular review meetings at highest level *inter alia* including Union Ministers, Chief Ministers of the States, Cabinet Secretary, Chief Secretaries and Secretary in charge in respective States/ UTs including conferences, workshops, video conferences, are held as well as field visits of multi-disciplinary teams are taken up wherein States are advised to plan and expedite the implementation to achieve the goal in a time-bound manner.
