- (c) the number of industries set up in Ranchi Parliamentary Constituency of Jharkhand after launching of Pradhan Mantri Mudra Yojana; and
- (d) the number of enterprises which have got assistance so far under Pradhan Mantri Atma Nirbhar Bharat Rojgar Yojana so far in the State of Jharkhand, district-wise?

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a): As on 03.02.2023, the total number of micro, small and medium enterprises registered on Udyam Registration Portal from 01.07.2020 to 03.02.2023 in Jharkhand was 2,36,015.
- (b): As per Prime Minister's Employment Generation Programme (PMEGP), the number of micro units set up in the state of Jharkhand during the year 2022-23 (upto 06.02.2023) was 883. The district wise details are attached as annexure I.
- (c): The number of loans sanctioned under Pradhan Mantri MUDRA Yojana (PMMY) from 01.04.2016 to 27.01.2023 in the following districts under Ranchi Parliamentary Constituency of Jharkhand are as follows:
