SETTING UP OF MEDICAL COLLEGES IN ASPIRATIONAL DISTRICTS

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether the target of establishing 58 medical colleges in 13 aspirational districts under Phase-I of Centrally Sponsored scheme for establishment of new medical colleges attached with existing districts/ referral hospitals during the year 2019-20 has been achieved;
- (b) if so, the details thereof, State/UT-wise, college-wise and if not, the reasons therefor;
- (c) whether the target of establishing 24 medical colleges in 6 aspirational districts during the year 2021-22 under Phase-II of the said scheme has been achieved;
- (d) if so, the details thereof, State/UT-wise, college-wise and if not, the reasons therefor;
- (e) whether the Government has been able to meet its expected budgetary allocations for the construction of such medical colleges; and
- (f) if so, the details thereof along with the details of funds released and utilized, State/UT-wise, college-wise including Maharashtra and Odisha?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (f): The Ministry of Health & Family Welfare administers a Centrally Sponsored Scheme (CSS) for 'Establishment of new Medical Colleges attached with existing district/referral hospitals' with preference to underserved areas and aspirational districts, where there is no existing Government or private medical college with fund sharing between Central Government and States is in the ratio of 90:10 for North eastern and Special category States and 60:40 for

other States. Under Phase-I of the Scheme, Medical colleges in 58 districts were approved, including 13 in aspirational districts. Under Phase-II of the Scheme, Medical colleges in 24 districts were approved, including 06 in aspirational districts. The State/UT wise details of Medical Colleges approved in aspirational districts under Phase-I & II of the Scheme along with the details of funds released, including Maharashtra and Odisha are at Annexure. However, under Phase-III of the Scheme, Medical colleges in 75 districts were approved, including 21 in aspirational districts, of which one Medical College each has been approved in Nandurbar, Maharashtra and Kalahandi, Odisha.

The entire Central Share for Medical Colleges approved under Phase-I and II of the Scheme has already been released. Further, as per the Scheme guidelines, the planning, execution and commissioning of the projects is to be done by the State Government.
