### 1488. SHRIMATI KESHARI DEVI PATEL:

Will the Minister of Women and Child Development be pleased to state:

- (a) whether the Government has launched Mission Shakti in the country;
- (b) if so, the details thereof indicating the funds earmarked and the targets fixed under the mission:
- (c) the details of the potential States to be included under the scheme along with the time by which it is likely to be implemented;
- (d) whether the Government has contemplated to include Rajasthan under the mission; and
- (e) if so, the details thereof

#### **ANSWER**

## MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) to (e): The Government of India has launched 'Mission Shakti' – an integrated women empowerment programme as umbrella scheme for the safety, security and empowerment of women for implementation during the 15th Finance Commission period i.e. upto the year 2025-26, across the country including the State of Rajasthan.

The 'Mission Shakti' has two sub-schemes namely "Sambal" for safety and security of women and "Samarthya" for empowerment of women. The 'Sambal' sub-scheme has components of One Stop Centre (OSC), Women Helpline (WHL), Beti Bachao Beti Padhao (BBBP) and Nari Adalat. Under 'Samarthya' sub-scheme, the components are Shakti Sadan (erstwhile schemes of Swadhar Greh and Ujjawala), Sakhi Niwas (Working Women Hostel), Pradhan Mantri Matru Vandana Yojana, Palna (Creche) and a new component i.e. Hub for Empowerment of Women (HEW).

The 'Mission Shakti' has been approved with the total financial implication of Rs.20,989 crore, out of which the Central Share is 15,761 crore. The details are at **Annexure**.
