OVERALL DEVELOPMENT OF CHILDREN

1522. SHRI G.M. SIDDESHWAR:

Will the Minister of WOMEN AND CHILD be pleased to state:

- (a) the details of various initiatives undertaken by the Ministry and its constituent bodies with regards to overall development of children in the country;
- (b) the progress status of these initiatives in terms of number of beneficiaries, funds allocated and facilities developed in the country, State-wise; and
- (c) whether the Ministry has prepared any detailed plan for coming years for furthering the overall development of children in the country, if so, the details thereof and if not, the reasons therefor

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

- (a) to (c) Government has approved `Mission Saksham Anganwadi and Poshan 2.0 realigning the schemes of Anganwadi Services, Poshan 2.0 and Scheme for Adolescent Girls. The important components of Mission Saksham Anganwadi and Poshan 2.0 are as under:
 - Nutrition Support for POSHAN through Supplementary Nutrition Programme (SNP) for children of the age group of 06 months to 6 years, pregnant women and lactating mothers (PWLM); and for Adolescent Girls in the age group of 14 to 18 years in Aspirational Districts and North Eastern Region (NER);
 - Early Childhood Care and Education [3-6 years] and early stimulation for (0-3 years);
 - Anganwadi Infrastructure including modern, upgraded Saksham Anganwadi; and
 - Poshan Abhiyaan

Saksham Anganwadi and Mission Poshan 2.0 announced in budget 2021-2022 for all States/UTs aim to address Government's commitment to address the challenge of child malnutrition and maternal under-nutrition through a strategic shift in nutrition content and delivery and create conditions and a convergent eco-system to develop practices that nurture health, wellness and immunity. The Scheme seeks to address

the challenging situation of malnutrition levels among children, adolescent girls and women as revealed by initial National Family Heath Survey NFHS-5 findings and optimize the quality and delivery of food under the Supplementary Nutrition Program. It seeks to strengthen nutritional content, delivery, outreach and outcomes with focus on developing practices that nurture health, wellness and immunity to disease and malnutrition. Steps have been taken to improve nutritional quality and testing in accredited labs, strengthen delivery and leverage technology under Poshan Tracker to improve governance. Guidelines were issued for transparency and accountability in delivery of supplementary nutrition and to track nutritional outcomes on 13.01.2021.

The Anganwadi Services under Saksham Anganwadi and Poshan 2.0, is a universal self-selecting Scheme available to all the beneficiaries who enroll at the Anganwadi Centres (AWCs). The beneficiaries under this scheme are children in the age group of 0-6 years, pregnant women and lactating mothers. Under the Scheme following six services is provided through the platform of Anganwadi Centres to the eligible beneficiaries:

- i. Supplementary Nutrition (SNP)
- ii. Pre-school Non-formal Education,
- iii. Nutrition & Health Education,
- iv. Immunization,
- v. Health Check-up, and
- vi. Referral Services

Three of the six services, viz., Immunization, Health check-up and Referral Services are related to health and are provided through NHM & Public Health Infrastructure.

The details of the funds released under Anganwadi Services for the current FY 2022-23 is placed at **Annexure I**.

Also, under Saksham Anganwadi and Poshan 2.0, 2 lakh selected AWCs (40,000 AWCs) per year would be strengthened and upgraded for improved nutrition and early childhood care and development of children under 6 years of age. In the current FY, approx 40,000 anganwadi centres have been identified for up-gradation.

POSHAN Abhiyaan launched on 8th March 2018, aims to achieve improvement in nutritional status of Adolescent Girls, Pregnant Women and Lactating Mothers in a time bound manner by adopting a synergized and result oriented approach.

The Ministry of Women and Child Development is implementing a centrally sponsored scheme namely 'Mission Vatsalya' (erstwhile Child Protection Services (CPS) Scheme) on pre-defined cost sharing pattern through the State and UT Governments for delivering services for children in difficult circumstances universally across the country. The Child Care Institutions (CCIs) established under the scheme support *inter-alia* age-appropriate education, access to vocational training, recreation, health care, counselling etc. and covers both rural and urban children. Further, the Ministry regularly engages with all State/UTs and from time to time has shared various advisories and guidelines for continued and uninterrupted delivery of services and also for effective implementation of the scheme. The number of children benefited under the scheme, as on 31.03.2022, is 76,118. The Mission Vatsalya Scheme has the approval upto 2025-26. State-wise release of funds under Mission Vatsalya Scheme during the last three years is at **Annexure-III.**
