STUDY ON POSHAN ABHIYAAN

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the Government has conducted any detailed State-wise study regarding performance/impact of POSHAN Abhiyaan;
- (b) if so, the details thereof;
- (c) the details of the achievement and objectives of POSHAN Abhiyaan in Maharashtra, district-wise;
- (d) the rate of dwarfism, under malnutrition, anaemia in children, adolescent girls and women and low birth-weight in infants in the above State and especially in Osmanabad Parliamentary Constituency during the implementation of POSHAN Abhiyaan;
- (e) the details of the funds released by the Union Government as well as the State Governments and the funds utilized for the purpose; and
- (f) the number of beneficiaries of the above scheme, State/UT-wise including Maharashtra?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

- (a) & (b) NITI Aayog was mandated to conduct monitoring and evaluation periodically to assess the progress and impact of POSHAN Abhiyaan. In the report Preserving Progress on Nutrition in India: Poshan Abhiyaan In Pandemic Times NITI Aayog assessed the implementation of POSHAN Abhiyaan since its inception and also analysed the impact of the COVID-19 pandemic on nutrition and health services. Following are the key findings of the report:
 - Poshan Abhiyaan has helped to bring a strong focus on improving nutrition outcomes during the first 1,000 days.
 - Poshan Abhiyaan has enabled a nation-wide jan-andolan catalysing nutrition related behaviour change at scale for positive impact on feeding and health care practices.
 - Poshan Abhiyaan demonstrated that the processes for inter-sectoral convergence are effectively operationalized through in place institutional mechanisms at multiple levels.
 - Poshan Abhiyaan showed that technology can be leveraged for real time monitoring of large scale health and nutrition programmes
 - Poshan Abhiyaan supported the resilience of health and nutrition systems during covid-19 pandemic

(c) POSHAN Abhiyaan was launched on 8th March 2018 with an aim to achieve improvement in nutritional status of Children under 6 years, Adolescent Girls, Pregnant Women and Lactating Mothers in a time bound manner by adopting a synergised and result oriented approach with targets as under.

Poshan Abhiyan is a centrally sponsored Scheme and the implementation of the Scheme lies with the State Government. Poshan Abhiyan has been rolled out in all 36 districts of Maharashtra. Information Technology systems have been leveraged to strengthen and bring about transparency in nutrition delivery support systems. The 'Poshan Tracker' application was rolled out on 1st March 2021 as an important governance tool. Close to 75.48 lakh beneficiaries have been registered on Poshan Tracker from the State of Maharashtra.

Under POSHAN Abhiyaan, for the first time, the Anganwadi workers and Centres were empowered and equipped with mobile devices and growth monitoring devices such as Infantometer, Stadiometer, Weighing Scale. In the state of Maharashtra, 120685 Smartphones and 110486 Growth Monitoring Devices have been procured.

Further, Behaviour change and communication through Jan Andolan is a key component of Poshan Abhiyan. At a national level, Poshan Pakhwada is celebrated every March and the Rashtriya Poshan Maah is celebrated every September. In Poshan Pakhwada 2022 and Poshan Maah 2022, close to 75.2 lakh activities and 6.5 crore activities, respectively were conducted across the States of Maharashtra. Key themes included Mahila aur Swasthya, Bacha aur Shiksha, Gender Sensitive Water Management and Healthy food for Mother and Child, particularly in Tribal regions.

(d) As per NFHS-5 (2019-21) prevalence of malnutrition and anaemia in children, adolescent girls and women and low birth-weight in infants in State of Maharashtra and in Osmanabad Parliamentary Constituency are as under:
