Will the **MINISTER OF HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Pradhan Mantri National Dialysis Programme (PMNDP) has been implemented in the country particularly in Tamil Nadu, Maharashtra and Andaman & Nicobar Islands and if so, the details and the current status thereof, State/UT-wise;
- (b) the total amount spent on each patient ailing from Chronic Kidney Disease along with the number of beneficiaries who have availed dialysis sessions under the aegis of the programme during each of the last three years and the current year, particularly in Tamil Nadu, Maharashtra and Andaman & Nicobar Islands;
- (c) the challenges faced by the Government while implementing the programme;
- (d) whether the PMNDP has not been implemented in some States and if so, the reasons therefor and the efforts made by the Government to implement PMNDP in such States/UTs;
- (e) whether the number of dialysis machines in the country is lesser than the actual requirement;
- (f) if so, the details thereof and the reasons therefor; and
- (g) the steps taken/being taken by the Government to effectively implement PMNDP in the country?

ANSWER

**THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE

(a) to (g): Pradhan Mantri National Dialysis Programme (PMNDP) was launched for chronic kidney disease during year 2016-17 to support all district hospitals under National Health Mission (NHM). PMNDP has been implemented in total 36 States/UT in 641 Districts at 1350 centres by deploying 8871 hemo-dialysis machines. Total 17.27 lakh patient availed dialysis services and 188.57 Lakh Hemo-dialysis sessions were held as on 31st December 2022. The

detail of state wise program implementation status is available in the link below: <https://nhsrcindia.org/pmndp-map-table>. The state-wise detail of beneficiaries under PMNDP is as per **Annexure**. National Health Mission (NHM) supports States/UTs in implementation of Haemodialysis and Peritoneal Dialysis services under PMNDP based on the gap assessment done by the State/UTs through the annual Programme Implementation Plans (PIP).

Dialysis services are provided free of cost to the below poverty level (BPL) beneficiaries. With the objective to ensure accessibility and portability under One Nation-One Dialysis concept, National PMNDP portal was launched on 5th May 2022 and is operational across the states for registration of dialysis patients using Ayushman Bharat Health Account (ABHA) ID.
