PLACEMENT RATE OF PMKVY

1625. SHRI KESINENI SRINIVAS:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the number of individuals given skill training under the Pradhan Mantri Kaushal Vikas Yojana, State-wise in all its 3 phases:
- (b) the details of the number of individuals who were trained and got placed post their training, Statewise;
- (c) whether it is a fact that the placement rate dropped in the case of short-term training (STT) courses;
- (d) if so, the reasons therefor; and
- (e) the remedial steps being planned by the Government in order to ensure a 100 per cent placement rate?

ANSWER

(a) and (b) Ministry of Skill Development and Entrepreneurship (MSDE) has been implementing Pradhan Mantri Kaushal Vikas Yojana (PMKVY) with an objective to deliver skills to youth of the country through Short Term Training (STT) and Recognition of Prior Learning (RPL).

Under the PMKVY 3.0, training have been imparted through Short Term Training (STT), Recognition of Prior Learning (RPL), Customized Crash Course Programme for COVID Warriors (CCCP-CW) and Skill Hubs Initiative. Under PMKVY 3.0, placement opportunities were facilitated to STT certified candidates. Under PMKVY (PMKVY 1.0, 2.0 and 3.0) as on 31.12.2022, 1.37 crore candidates have been trained/oriented; out of which 24.36 lakh certified candidates have been reported placed across the country. The State wise detail of candidates trained/oriented and reported placed under the PMKVY as on 31.12.2022 is placed at **Annexure**.

- (c) and (d) The placement rate in STT certified candidates under PMKVY 1.0 was 19%. This rate has been increased to 53%under PMKVY 2.0. However, the placement rate of certified candidates under PMKVY 3.0 was decreased to 28% due to wide spread disruption in economy due to COVID 19 pandemic.
- (e) In order to increase the opportunities for placements of the certified candidates under the PMKVY, Sector Skill Councils (SSCs) and District Skill Committee (DSC)support in the identification of job roles based on requirements in various sector. Further, Rozgar Melas and Apprenticeship Melas are being organized at district and regional level. In addition, Ministry has launched Aatmanirbhar Skilled Employees Employer Mapping (ASEEM) portal, which acts as a central directory of skilled workforce registered and certified under Skill India Portal (SIP), across all schemes at Central and State level.
