SCHEME OF SIDDHARTHANAGAR VILLAGES

1737. SHRI JAGDAMBIKA PAL:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether the Government has included any villages of Siddharthanagar under the schemes formulated by the Government;
- (b) if so, the details thereof and the progress made so far in these villages;
- (c) the details of the amount sanctioned by the Government under the programme during the last five years in Uttar Pradesh; and
- (d) whether the Government proposes to include any alternative of the scheme, if so, details thereof and if not, the reasons therefor?

ANSWER

(a) to (c): Government has revamped the earlier Scheme of 'Special Central Assistance to Tribal Sub-Scheme (SCA to TSS) with nomenclature 'Pradhan Mantri Adi Adarsh Gram Yojna (PMAAGY)', for implementation during 2021-22 to 2025-26, which aims at integrated development of villages with significant tribal population. It is envisaged to cover 36,428 villages having at least 50% tribal population and 500 STs across States / UTs with notified STs. This includes 182 villages in Uttar Pradesh. Since there is a criteria of 50% tribal population and 500 STs in a village for selection under the scheme of PMAAGY, villages of Siddharthanagar are not covered under the scheme. The District-wise details of the villages selected under the scheme of PMAAGY in State of Uttar Pradesh is under:
