Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the number of Skill Development Centres functional in various States of the country particularly in Dadra and Nagar Haveli, Daman and Diu and Maharashtra;
- (b) the total amount spent during the last three years for the said purpose; and
- (c) the number of beneficiaries in the above mentioned places who have been provided benefit in their startups by the Government?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) Under Skill India Mission, the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill training through a comprehensive network of skill development centres/ institutes across the country including Dadra and Nagar Haveli, Daman and Diu and Maharashtra under various schemes viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS) Scheme, National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs). Through these centres, training to candidates is imparted in employable skills, as per requirements of industry and economy. The State-wise number of Training Centres is at **Annexure-I**.

(b) Total funds disbursed to States during the last three years viz. 2019-20, 2020-21 and 2021-22 under PMKVY and JSS is Rs. 3103.18 Crore and Rs. 343.11 Crore respectively. Day-to-day administration as well as financial control in respect of ITIs lies with the respective State Governments/Union Territory Administration. Under NAPS, establishments are incentivised by way of stipend support.

(c) The MSDE does not maintain information of beneficiaries of startup under its scheme. However, mandate of schemes under Skill India Mission is to equip youth of the country with employable skill for improvement in their livelihood. As per the third-Party Evaluation Report on PMKVY 2.0 (2016-20), it was found that average monthly income of PMKVY trained and certified individuals was 15% higher than the comparison group. Moreover, 76% of the candidates acknowledged that after the training, they have better chance of getting employment. Third party evaluation reports of other schemes of MSDE, has also found that there is success in terms of placement or enhancement of income of candidates trained. As far as the employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme has observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident. The usefulness of the scheme is further evident from the fact that same report has mentioned that 77.05% of the beneficiary trainees have undergone occupational shifts. The final report of Tracer Study of ITI Graduates (published in January, 2018 by MSDE mentions that 63.5% of total ITI pass-outs got employed (wage+self, out of which 6.7% are self-employed).
