BUDGET ALLOTTED FOR PM POSHAN SCHEME

1893.SHRIMATI MALA ROY:

Will the Minister of EDUCATION be pleased to state:

- (a) whether it is true that the Budget allocation for PM POSHAN Scheme for the Financial Year 2023-24 is nine per cent lower than the Revised Estimates for the Financial Year 2022-23;
- (b) if so, the reason therefor; and
- (c) the details of the disbursement for above scheme till 28/02/2023, State-wise?

ANSWER

(a) to (c): pThe budget allocated under the PM POSHAN Scheme for 2022-23 is Rs. 10,233.75 crore. During financial year 2021-22, 2nd Installment could not be released/partially released to several States and UTs resulting in committed liabilities in 2022-23. Further, material cost has been enhanced @9.6% over and above the existing material cost for the year 2022-23 w.e.f. 1st October, 2022. Hence, more funds were required for the year 2022-23. Therefore, Ministry of Finance has approved the Revised Estimate (RE) 2022-23 as Rs.12,800.00 crore against the Budget Estimate (BE) of Rs. 10233.75 crore which is sufficient to implement the scheme with existing norms during 2022-23. The BE for the financial year 2023-24 is allocated as Rs. 11600.00 crore which is likely to be sufficient for implementation of the scheme with existing norms during 2023-24. The State-wise details of the funds released under the scheme till 28/02/2023 is given at Annexure.
