- (a) whether the Government has made any financial expenditure planning for the art and culture promotion scheme, promotion of museums, international cooperation, centenary and annual programmes of the Ministry during the year 2022-23;
- (b) if so, the details thereof;
- (c) whether the Government has made any action plan across the country for Central autonomous bodies, museums, academies, libraries and other institutions of culture; and
- (d) if so, the details thereof ?

ANSWER

MINISTER OF CULTURE, TOURISM AND DEVELOPMENT OF NORTH EASTERN REGION (SHRI G. KISHAN REDDY)

(a) & (b): Yes, Sir, the Budget Estimates of the Ministry of Culture for the year 2022-23 is annexed.

(c) & (d): Yes, Sir. As per the mandate of Ministry of Culture, the Ministry deals with the Tangible and Intangible Cultural Heritage of India. This heritage encompasses several strands including monuments and archaeology, folk and tribal art, literature, archives, library, performing arts including music dance and drama, visual arts in the form of paintings, sculptures and graphics. All activities of the Ministry relating to promotion, preservation and conservation of the Cultural Heritage of the Country are implemented through a network of two attached offices, 7 subordinated offices and 34 autonomous organizations under its control and number of schemes directly operated by the Ministry for promotion and dissemination of Art & Culture. Its activities, projects and programmes are organized under various schemes of archaeology, museums, archives, anthropology, performing arts, public libraries, Buddhists and Tibetan institutes, centenaries and anniversary, international cultural relations, Gandhi heritage mission
