Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) whether the Pradhan Mantri Kaushal Vikas Yojana (PMKVY) is functioning in Pratapgarh district of Uttar Pradesh;
- (b) if so, the number of training centres started under PMKVY 3.0 in Pratapgarh district of Uttar Pradesh during 2021-22 and the number of candidates enrolled in these training centres during the same time period;
- (c) the details of the responsibilities assigned to the State Government under PMKVY 3.0;
- (d) the details of the placement assistance provided to the candidates in the training centres; and
- (e) whether any Rozgar or Kaushal melas organised in Pratapgarh district of Uttar Pradesh and Pali district of Rajasthan during 2021-22, if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI DHARMENDRA PRADHAN)

- (a) Yes, Sir. Ministry of Skill Development and Entrepreneurship (MSDE) has been implementing Pradhan Mantri Kaushal Vikas Yojana (PMKVY) for imparting skill training to youth across the country including Pratapgarh district of Uttar Pradesh.
- (b) Under PMKVY 3.0, training was imparted through one training centre in the Pratapgarh district of Uttar Pradesh. Under PMKVY 3.0, 359 candidates were enrolled in the Pratapgarh district of Uttar Pradesh.
- (c) PMKVY 3.0 had two components, namely, Central component was implemented through National Skill Development Corporation (NSDC) and State component was implemented through State Skill Development Missions (SSDMs)/respective Departments of the States / UTs. Under PMKVY 3.0, targets were given to SSDMs. SSDMs further allocate the targets to the district, based on demands received from District Skill Committee (DSC). Further, in order to improve the monitoring under PMKVY 3.0, District Skill Committee (DSC) had been involved and entrusted

with the monitoring of the Scheme. DSCs also supported in the identification of job roles based on requirements in various sector.

(d) Under PMKVY, training centres make efforts to facilitate the placements of certified candidates. RojgarMela and Apprenticeship Mela are also held to support the candidates to get the job opportunities. Other incentives as per Common Norms like one-time placements travel cost and post placement stipend were also provided to women, PwD, transgender and deprived group of candidates.

(e) No Rozgarmela or Kaushal mela was organized In Partapgarh district of Uttar Pradesh and Pali district of Rajasthan during 2021-22.
