### ALLOCATION OF FUNDS FOR LITERACY PROGRAMMES

†2016. SHRI HAJI FAZLUR REHMAN:

Will the Minister of EDUCATION be pleased to state:

- (a) the details of the allocation approved and released by the Government for various literacy programmes during the current year, State-wise;
- (b) the present literacy rate of the country and the names of States where there has been a significant increase in the literacy rate during the last three years;
- (c) whether the Government has received proposals from the States to open educational centres to improve the level of education during each of the last three years; and
- (d) if so, the details thereof and the steps taken by the Government in this regard?

### **ANSWER**

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

(a) to (d): A statement indicating details of State/UT-wise funds sanctioned/ released as Central share under the Scheme of New India Literacy Programme and Samagra Shiksha during the current financial year 2022-23 is at **Annexure-I**. The literacy data in the country is collected through decennial census operation conducted by the Registrar General of India. The last Census was held in 2011. As per the Census 2011, the literacy rate in the country is 72.98 per cent. In the years 2020 to 2022, Padhna Likhna Abhiyan was implemented in which around 35 lakh people were benefitted by the program. "Nav Bharat Saaksharta Karyakram" has been approved from 2022 to 2027 to be implemented in all State/UTs for all non-literates above 15 years and the target for 5 years is 5 crores.
