Ban on Single Use Plastic

2018. SHRI SRIDHAR KOTAGIRI:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether the Government is taking measures to enforce ban on manufacturing, import, stocking, distribution, sale and use of single use plastic in the country, if so, the details thereof;
- (b) whether the Government is taking measures to promote research on the alternatives of such single use plastic; and
- (c) if so, the details thereof and if not, the reasons therefor?

ANSWER

The Plastic Waste Management Rules, 2016, as amended, provide the statutory framework and the prescribed authorities for enforcement of the rules, including ban on identified single use plastic items, which became effective from 1st July 2022. Further, States and Union Territories have been asked to undertake regular enforcement drives to implement ban on identified single use plastic items and on plastic carry bags having thickness less than one hundred twenty microns, covering fruit and vegetable markets, wholesale markets, local markets, flower vendors, units manufacturing plastic carry bags etc. States and UTs have also been asked to undertake random checking at border checkpoints to stop inter-state movement of banned single use plastic items. A one-month long pan India enforcement campaign was undertaken for implementation of ban on identified single use plastic items from 1st to 31st July 2022. Special pan India enforcement drives was undertaken in months of October, November and December, 2022 by Central Pollution Control Board, State Pollution Control Boards and Pollution Control Committees. During the enforcement campaigns, noncompliance of the ban on identified single use plastic has been found in commercial establishments and manufacturing units including in small shops in local markets. Actions have been taken on the deviations, which include seizure of banned single use plastic items and levy of penalty. Further the Producers/Importers/Brand owners engaged in producing / importing / using banned single use plastic items have not been granted registration on the centralized EPR portal for plastic packaging.

For effective monitoring of ban on identified single use plastic items and plastic waste management in the country the following online platforms are in operation (a) National Dashboard for monitoring of implementation of comprehensive action plan (b) CPCB Monitoring Module for Compliance on Elimination of Single Use Plastic, and (c) CPCB Grievance Redressal App.

(b) & (c): The Department of Science and Technology and Department of Biotechnology support research and development projects for alternatives to banned single-use plastic items, as per scheme guidelines. NITI Aayog has also brought out a report on alternative products and technologies to plastics and their applications. The Ministry of Micro, Small and Medium Enterprises has schemes to provide support to MSME units, which include support to such units which were earlier involved in manufacturing of banned single use plastic items for switching over to alternatives / other products. Further, to encourage innovation in development of alternatives to banned identified single use plastic items and digital solutions to plastic waste management, the Ministry of Environment, Forest and Climate Change organized an India Plastic Challenge – Hackathon 2021, for students of higher education institutions and start-ups.
