### **Educational Schemes/Projects in the Country**

2052. SHRI GIRISH CHANDRA:

Will the Minister of EDUCATION be pleased to state:

- (a) the details of the schemes/projects being run by the Government to promote education in the country especially in the rural areas of Uttar Pradesh;
- (b) the details of the action plan formulated in the year 2022-23 to develop infrastructure like smart board and online education through applications for basic education in rural areas and to improve the quality of education being imparted by teachers in the rural schools, State-wise;
- (c) the amount of budget allocated for the said purpose by the Government; and
- (d) the steps proposed to be taken by the Government to provide online education to the students of all Government schools in the country?

#### **ANSWER**

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

(a) to (d): Education is in the Concurrent list of the Constitution and majority of the school are under the administrative control of respective State Government and UT Administration.

The Department of School Education and Literacy with effect from 2018-19 has launched an Integrated Centrally Sponsored Scheme for School Education- Samagra Shiksha. The scheme has now been aligned with the recommendations of National Education Policy (NEP) 2020 to ensure that all children have access to qualitative and an equitable education. The scheme is being implemented in partnership with all the States and UTs including the State of Uttar Pradesh. Under the scheme, financial assistance is provided to States and UTs for undertaking various activities for universalisation of school education including setting up of ICT Labs and Smart Class rooms.

The financial assistance is based on the annual plans prepared by the States and UTs as per their requirements/ priority and is reflected in their respective Annual Work Plan and Budget (AWP&B) Proposals. These plans are then appraised and approved/estimated by the Project Approval Board (PAB) in the Department of School Education & Literacy in consultation with the States and UTs as per the programmatic and financial norms of the scheme and physical and financial progress of the State for the interventions approved earlier.

The estimated outlay approved for ICT and Digital initiatives and for NISHTHA for the year 2022-23 is at **Annexure I** and **Annexure II** respectively.

The ICT and Digital Initiatives component of Samagra Shiksha covers Government and Government aided Schools having classes VI to XII as per the following provisions:

#### A. Budgetary provisions

The non- recurring/recurring grant under 'ICT and Digital Initiatives' for schools is available to the States and UTs for following two options:

**Option I:** Under this option, schools which have not availed the ICT facility earlier can either opt for ICT or smart classrooms as per their requirement and need. In case of more than 700 enrolments, an additional ICT lab can also be considered. **Option II:** Under this option, schools which have already availed the ICT facility earlier can avail smart classrooms/tablets as per the norms of the scheme. **B. Financial provisions** 

**ICT Lab:** A non-recurring grant of up to ₹ 6.40 lakh per school and recurring grant of upto ₹ 2.40 lakh per school per annum for a period of 5 years. Smart Classrooms: The non-recurring grant for Smart Class rooms is of ₹ 2.40 lakh and the recurring grant is ₹ 0.38 lakh. To facilitate online education, a comprehensive initiative called PM eVIDYA has been initiated as part of Atma Nirbhar Bharat Abhiyaan on 17th May, 2020, which unifies all efforts related to digital/online/on-air education to enable multi-mode access to education. The initiative includes:

- DIKSHA (one nation, one digital platform) is the nation's digital infrastructure for providing quality e-content for school education in states/UTs and QR coded Energized Textbooks for all grades are available on it.
- One earmarked Swayam Prabha TV channel per class from 1 to 12 (one class, one channel).
- Extensive use of Radio, Community radio and CBSE Podcast- Shiksha Vani.
- Special e-content for visually and hearing impaired developed on Digitally Accessible Information System (DAISY) and in sign language on NIOS website/ YouTube.

Further, this Department has launched a National Mission to improve Learning Outcome at elementary level through an integrated teacher training Programme called NISHTHA- National Initiatives for School Heads and Teachers' Holistic Advancement. NISHTHA is being provided in online mode on various aspects including ICT in teaching-learning.
