FOOD PROCESSING UNITS IN GUJARAT

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether the Government has set up any food processing units in Gujarat under the Mega Food Park scheme during the last three years;
- (b) if so, the details thereof;
- (c) whether the Government has any proposal to set up new food processing units in Gujarat; and
- (d) if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

(a) to (d): The Ministry of Food Processing Industries (MoFPI) on its own does not set up any food processing projects under any of its scheme, which are demand driven. However, MoFPI invites application through Expression of Interest for providing financial assistance in the form of grants-in-aid for setting up of projects under various sub-schemes of Pradhan Mantri Kisan Sampada Yojana (PMKSY) based on the availability of vacant slots and budget. Under sub-scheme – Creation/Expansion of Food Processing and Preservation Capacities (CEFPPC scheme) of PMKSY, MoFPI has sanctioned financial assistance for setting up of 8 food processing units (7 units in M/s Gujarat Agro Infrastructure Mega Food Park Pvt. Ltd., Surat and 1 unit in M/s Fanidhar Mega Food Park Pvt. Ltd., Mehsana) during the last three years from 2019-20 to 2021-22 in the MoFPI approved Mega Food Parks in the State of Gujarat. Details of food processing units financially assisted through CEFPPC scheme under the Mega Food Parks assisted by MoFPI in the state of Gujarat are provided at **Annexure**.
