Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the number of Mega Food Parks set up in the country during the last six months in various States particularly in Maharashtra and Odisha;
- (b) whether there is any proposal for a Public Private Partnership (PPP) model being adopted for the running of these Mega Food Parks in some or all of the States particularly in Maharashtra and Odisha:
- (c) If so, the details thereof; and
- (d) the details of funds allocated by the Union Government, released and utilized so far on setting up of Mega Food Parks during each of the last three years, State-wise particularly in Maharashtra and Odisha?

#### **ANSWER**

### THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

- (a). The Ministry of Food Processing Industries has approved a total of 41 Mega Food Park projects so far, out of which 23 have become operational. None of the Mega Food Park projects has become operational during last six months in the country, including Maharashtra and Odisha.
- (b). No sir.
- (c). Does not arise.
- (d). State/UT-wise allocation of funds is not done under the Mega Food Park scheme. The details of grants-in-aid released towards setting up of various Mega Food Parks during each of the last three years, based on their locations, including in Maharashtra and Odisha are given at **Annexure**.
