SPREAD OF LUMPY DISEASE

2130. SHRI HEMANT SRIRAM PATIL:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) whether it is a fact that cattle are suffering from Lumpy Disease in the country;
- (b) if so, whether any survey has been conducted on the spread of this disease in the States particularly in Maharashtra;
- (c) whether any expert committee/experts have visited the State to assist in the treatment of cattle suffering from the disease; and
- (d) if so, the actual position thereof in the State with regard to suffering / treatment along with other precautions to be taken by the State authorities?

ANSWER

THE MINISTER FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

- (a) and (b): Yes, Sir. As gathered from the States/UTs including Maharashtra, the information regarding number of cattle affected, died, vaccinated and recovered in respect to Lumpy Skin Disease (LSD) is attached as **Annexure 1**. No survey has been conducted on the spread of the disease. However, the disease is transmitted by vectors like mosquitoes, biting flies, ticks, etc and accordingly the control measures are advised to the states/UTs.
- (c) and (d):Yes, Sir. The central expert team of the Department of Animal Husbandry & Dairying, Government of India including the scientist from Indian Council of Agricultural Research (ICAR) have visited the State of Maharashtra from 21.11.2022 to 23.11.2022 to advise the state on how to control the disease in definite time line including advice regarding treatment of the cattle suffering from the disease. The State, based on Centre's advisories on control, vaccination and treatment has directed field functionaries and stakeholders for preparedness, control & containment of LSD. Rapid Response Teams (RRTs) were constituted at block and district levels for surveillance, collection of samples, vaccination and treatment for control of the disease. The vaccination with available Goat Pox Vaccine is underway. The vaccination and treatment is provided free of cost by the state.
