Beneficiaries of PMMSY

2190. SHRI JAYADEV GALLA:

Will the Minister of **FISHERIES, ANIMAL HUSBANDRY AND DAIRYING**
मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) the details of Livelihood and Nutritional Support provided to families under Pradhan Mantri Matsya Sampada Yojana (PMMSY) during the last financial year to the State of Andhra Pradesh;
- (b) the total number of nation-wide cumulative beneficiaries of this Yojana, State-wise and district-wise;
- (c) the total number of Scheduled Caste (SC) and Scheduled Tribe (ST) women beneficiaries who have been roped in under the said Yojana and specific financial support being provided to them, State-wise, if any; and
- (d) whether a model fisheries village has been developed under the PMMSY in the State of Andhra Pradesh and if so, the details thereof?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(SHRI PARSHOTTAM RUPALA)

(a) to (c): The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying (MoFAH&D) during the last financial year (2021-22) under the Pradhan Mantri Matsya Sampada Yojana (PMMSY) has approved Livelihood and Nutritional support proposal of Government of Andhra Pradesh at total outlay of Rs.4426.20 lakh involving central share of Rs.1475.40 lakh for providing relief assistance to 98,360 eligible fishers. Further, total number of cumulative beneficiaries of PMMSY state wise including Scheduled caste, Scheduled Tribe and women beneficiaries and financial support provided are at **Annexure**.

(d): The PMMSY *inter-alia* envisages development of Integrated Modern Coastal Fishing Villages in the maritime States/UTs. The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying has not sanctioned model fisheries village project under PMMSY to Andhra Pradesh.
