#### **ROADS IDENTIFIED UNDER PMGSY**

#### 2282. SHRI GIRISH CHANDRA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of construction of roads under Pradhan Mantri Gram Sadak Yojana (PMGSY) in the State of Uttar Pradesh (UP);
- (b) the steps taken/being taken by the Government to remove the obstacles coming in its way along with the details of the outcome thereof;
- (c) the number of roads identified under the said Yojana during each of the last three years and the current year; and
- (d) the details of the projects identified under the said Yojana, district-wise?

#### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a) Since inception till 07.03.2023, 19,416 road works of length 64,634 Km have been constructed under various interventions/ verticals of Pradhan Mantri Gram Sadak Yojana (PMGSY) in the State of Uttar Pradesh.
- (b) The progress of implementation of rural roads under PMGSY is regularly reviewed by way of Regional Review Meetings (RRMs), the Performance Review Committee (PRC) Meetings, Pre-Empowered /Empowered Committee Meetings with the States. At District level, the District Development Coordination and Monitoring Committee (DISHA) headed by a Member of Parliament (LS) monitors the implementation of various schemes of Government of India including PMGSY. In addition to this, special review meetings/monthly review meetings are also held by Secretary/Additional Secretary/Joint Secretaries, Ministry of Rural Development with Chief Secretaries/ Principal Secretaries of the States. In these meetings, hand holding of the State is done and efforts are made to remove the obstacles. As a result, 100% of the works sanctioned under PMGSY-II & II and 70% of the works sanctioned under RCPLWEA have been completed. Under PMGSY-III, 40% of the sanctioned works have been completed, as these works have been sanctioned in recent past. The timeline for completion of RCPLWEA is March, 2023 and for PMGSY-III, it is March, 2025.
- (c) In the year 2019-20, the balance 257 km road length was sanctioned to the state out of the target of 7,575 under PMGSY-II, whereas in the year 2020-21 and 2021-22, 18,563 km of road works under PMGSY-III have been sanctioned to the State out of the allocated target of 18,937.5 km.

The details of road works sanctioned under PMGSY ( PMGSY-II and PMGSY-III) during the last three years and the current year is given as under :-
