(a): The Central Government on 19th January 2022, has approved the continuation of Central Sector Scheme namely 'Indian Footwear and Leather Development Programme (IFLDP)' till 31.03.2026 or till further review, whichever is earlier. Indian Footwear and Leather Development Programme has been approved for implementation with six sub-schemes as under:

- i. Sustainable Technology and Environmental Promotion (STEP)
- ii. Integrated Development of Leather Sector (IDLS)
- iii. Establishment of Institutional Facilities (EIF)
- iv. Mega Leather Footwear and Accessories Cluster Development (MLFACD)
- v. Brand Promotion of Indian Brands in Leather and Footwear Sector
- vi. Development of Design Studios

development- program. All sub-schemes have been on-boarded on National Single Window System (NSWS). Eligible entrepreneurs can submit application through NSWSonline portal which is accessible at <https://www.nsws.gov.in/> -> "All schemes" ->

Select "Indian Footwear and Leather Development Programme" -> Select the applicable sub-scheme". Last date of submission of application under IFLDP was 15th December 2022.

- (b):** The state wise/UT wise details of application including the State of Andhra Pradesh along with their present status are at **Annexure-I**.

- (c):** The programme provides direct benefits towards employment generation especially for women, skill development, making the industry more environment friendly and prompting sustainable production systems.

- (d):** The core objective of the IFLDP is to enable creation of world class infrastructure to cater to the exports and domestic market, facilitate additional investments into the industry via modernization, technology upgradation and capacity expansion, setting up of new units, address environmental concerns specific to the leather sector, promote Indian Brands, set up Design Studios in the country. Applications for modernization/technology upgradation of units and upgradation of Common Effluent Treatment Plants are in pipeline to provide sustainable support to the Industry. Apart from proposal for development of Mega cluster and establishment of institutional infrastructure, applications for brand promotion of Indian brands in international market have been received for consideration. As an R&D activity, applications have been received for newly designed sub-scheme for development of design studio. These are considered to add efficiency to the leather and footwear sector.
