- (a) whether the Government has planned to set up modern storage rooms (SILOS) across the country and if so, the details thereof;
- (b) the details of its storage capacity and the estimated amount for construction; and
- (c) whether the Government has identified locations for its construction across the country and if so, the details thereof and the target fixed in Rajasthan?

(a) & (b): Yes, Sir. In order to upgrade and modernize the storage facilities, Government of India approved an Action Plan for the construction of steel silos in PPP (Public Private Partnership) mode through Food Corporation of India (FCI) in the country. Under this plan Silos of 12.75 LMT capacity are completed. The details of completed, under-construction silos across the country are in Annexure-I and Annexure-II respectively

Further, silos in PPP mode is proposed under Hub & Spoke model to be implemented in phased manner. In phase-I tenders for 10.125 LMT at 14 locations on FCI own land and 24.75 LMT at 66 locations of private land have been awarded. In phase-II, 30.75 LMT at 66 locations are proposed.

(c): Yes, Sir. Locations of phase-I and phase-II proposed in Rajasthan are at Annexure-III.
