- (a):** The status of progress made in respect of projects sanctioned under PM Gati Shakti in the State of Haryana is at Annexure –I.
- (b) & (c):** At Present, the use of PM Gati Shakti National Master Plan(NMP) platform is permitted only for planning Multimodal Infrastructure and social infrastructure projects by the Central Ministries/Departments and authorised personnel of Public Sector undertakings (PSUs) of Central Government, State Governments and Union Territory Administration.
- (d) & (e):** The National Master Plan(NMP) portal is hosted at 'Meghraj' (NIC Data Centre) and security of NMP system is ensured by security mechanisms in place.
