**2584. SHRI MARGANI BHARAT:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether Motor Spirit (MS) and High Speed Diesel (HSD) requirement of newly authorized entities for transportation fuel marketing under marketing resolution no. P-12029(11)/2/2018-OMC-PNG dated 08.11.2019 is considered domestic demand or not;
- (b) the reasons for non-supply of MS and HSD to new entities by Public Sector Undertaking (PSU) Oil Marketing Companies (OMCs);
- (c) whether the supplies are made/proposed to such entities on selective basis and if so, the criteria fixed for such selective supplies to some entities and not to others; and
- (d) the details of export and Refinery Transport Price (RTP) of MS and HSD during the last two years, month-wise?

- (a) Vide Resolution dated 08.11.2019, Government has issued guidelines for grant of authorization to market transportation fuels viz, MS and HSD to the new entrants including private sector for Retail and Bulk business.
- (b) Authorization to market transportation fuels under the said Resolution does not create any obligation/commitment on Public Sector Oil Marketing Companies (PSU OMCs) to sell/supply transportation fuels to newly authorized entities. Further, vide DGFT notification dated 30.06.2022, oil companies including PSU OMCs are only obligated to supply 50% of MS and 30% of HSD mentioned in the respective Shipping Bills in the domestic market during the current financial year.
- (c) Does not arise in view of (b) above.

- (d) Refinery Transfer Price (RTP) is the price paid by oil marketing companies to refiners for purchase of petroleum products. RTP is worked out for each port and every inland refinery and varies from port to port mainly on account of ocean freight to respective port and for inland refineries on freight from nearest port to location of the refinery.

Along with deregulation of retail prices of Petrol and Diesel, refinery gate price was also deregulated with effect from 26th June 2010 and 19th October 2014 respectively.
