PENDING PAYMENT TO MSMEs IN TELANGANA

2599. DR. G. RANJITH REDDY:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether it is true that more than Rs. 700 crore are pending for payment to MSMEs in Telangana as of November, 2022;
- (b) if so, the details of such payment, district wise;
- (c) the details of pending payment till 1st March, 2023 to MSMEs in Telangana;
- (d) the time since when the amount is pending for payment;
- (e) whether the Government is considering any deadline to all those who have to clear dues to MSMEs with interest, within thirty days and if so, the details thereof; and
- (f) if not, the reasons therefor?

ANSWER

(a) & (b): Micro and Small Enterprises (MSEs) can file applications in Micro and Small Enterprise Facilitation Councils (MSEFCs) for delayed payments. After the application is admitted by the MSEFCs, it becomes a case. As per the information available on the SAMADHAAN Portal since its launch on 30.10.2017 to 30.11.2022, the details of total no. of pending applications in Telangana (district wise) are at Annexure .

(c) & (d): As per the information available on the SAMADHAAN Portal from its launch on 30.10.2017 to 01.03.2023, Rs. 110.46 crore is pending to MSEs in Telangana.

(e) & (f): As per the provisions of Micro, Small and Medium Enterprises Development (MSMED) Act 2006, when a buyer does not make payment to the supplier (Micro & Small Enterprises) for his supplies within 45 days of the acceptance of the goods/service rendered, then the buyer is liable to pay a compound interest with the monthly rests to the supplier on the amount at three times of the bank rate notified by RBI.
