Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the Government is aware that there is no progress in piped natural gas connections in Bihar, particularly in district Gopalganj and if so, the reasons therefor;
- (b) whether it is a fact that targeted date is not yet achieved and if so, the reasons therefor;
- (c) whether the Government has instructed the authorized company to speed up the process for piped natural gas connections in Bihar; and
- (d) if so, the details thereof and if not, the reasons therefor?

(a) to (d) Provision of Piped Natural Gas (PNG) connections is part of the development of City Gas Distribution (CGD) Network and the same is being carried out by the entities authorised by Petroleum and Natural Gas Regulatory Board (PNGRB). After completion of 11-A CGD bidding round, 14 Geographical Areas (GAs) covering entire state of Bihar, including Gopalganj which comes under Gopalganj, Siwan, West Champaran, East Champaran and Deoria (in UP) districts, have been authorised by PNGRB.

Bharat Petroleum Corporation Limited (BPCL) is the authorised entity for Gopalganj, Siwan, West Champaran, East Champaran and Deoria (in UP) districts GA. PNG connections are commissioned by the authorised entities as per the Minimum Work Programme (MWP) mandated by the PNGRB. The authorized entities have to achieve the MWP target in Bihar, including Gopalganj by 2030.

The GA-wise details of MWP Target, Pro-rated Target and Achievement is at Annexure.
