Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

(a) the details of various schemes being run by the Ministry of Micro, Small and Medium Enterprises (MSMEs);

(b) the details of registration made by various industries with the Ministry during the last five years;

(c) whether the Ministry does registration in respect of youtube and news portal and if so, the details thereof;

(d) the number of youtube, news portal and other social media registered during the last five years; and

(e) whether the news portal gets any recognition after getting registration from the Ministry of MSME and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

(a): Ministry of MSME through its field offices network, implements various schemes/programmes for the promotion and development of Micro, Small and Medium Enterprises (MSMEs) sector across the country which inter alia include Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Credit Guarantee Scheme for Micro and Small Enterprises (CGTMSE), A Scheme for Promotion of Innovation, Rural Industries and Entrepreneurship (ASPIRE), Entrepreneurship and Skill Development Programme (ESDP), National Schedule Caste and Schedule Tribe Hub (NSSH). These schemes are aimed at inter alia facilitating easy credit access, market access, technological support to MSMEs and developing entrepreneurship attitude/skill among the youth towards generating self-employment opportunities.
