#### **HOUSES UNDER PMAY**

#### NO. 2670. MS. MIMI CHAKRABORTY:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a)the total number of houses sanctioned under the Pradhan Mantri Awas Yojana (PMAY) during the last three years, State-wise;
- (b)the allocation of the total number of houses and budget sanctioned against total number of applications during the last three years, Statewise; and
- (c)the details of the total number of houses completed and allotted to beneficiaries during the last three years, State-wise?

#### ANSWER

### THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) to (c): Ministry of Housing and Urban Affairs (MoHUA) is implementing Pradhan Mantri Awas Yojana - Urban (PMAY-U) since 25.06.2015 to provide pucca house with basic amenities to all eligible urban beneficiaries across the country. The implemented through four verticals i.e., scheme is **Beneficiary Led** Construction (BLC), Affordable Housing in Partnership (AHP), In-Situ Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS) based on eligibility criteria as per scheme guidelines. PMAY-U is a demand driven scheme and Government of India has not fixed any target for construction of houses. Based on the project proposals submitted by States/UTs, more than 1.20 crore houses have been sanctioned as on 06.03.2023. Of the sanctioned houses, 109.10 lakh have been grounded for construction; of which 71.56 lakh are completed/delivered to the beneficiaries. The details of State-wise houses sanctioned, grounded, completed/delivered to the beneficiaries along with Central Assistance approved during last three years is at Annexure.
