NO. 2687. SHRI SUNIL BABURAO MENDHE:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the salient features of Prime Minister Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Yojana;**
- (b) the number of beneficiaries covered so far under the PM SVANidhi Yojana in Maharashtra, district-wise along with the total amount released under it; and**
- (c) whether the Government has been successful in achieving the objectives of PM SVANidhi Yojana for which this scheme was introduced and if so, the details thereof and if not, the corrective measures taken in this regard?**

ANSWER

**THE MINISTER OF STATE IN THE

(SHRI KAUSHAL KISHORE)**

(a): Ministry of Housing and Urban Affairs (MoHUA) launched the Prime Minister Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Scheme on 1st June, 2020 with the aim to facilitate collateral free working capital loan to street vendors to restart their businesses, which were adversely impacted during the Covid-19 pandemic. The Scheme has the following objectives:

- i. Facilitate collateral free working capital loan up to ₹10,000 of 1 year tenure, with enhanced loan of ₹20,000 and ₹50,000 in the second and third tranches respectively, on repayment of earlier loans.**
 - ii. Incentivize regular repayment, through interest subsidy @ 7% per annum; and**
 - iii. Reward digital transactions, by way of cash back up to ₹1,200 per year**
- (b) As on 7th March, 2023, in the State of Maharashtra, there are 3,32,309 number of beneficiaries to whom loans amounting to ₹444.5 Cr have been disbursed/released so far under PM SVANidhi Scheme. The district-wise details of beneficiaries and amount disbursed/released for the State of Maharashtra is at Annexure-I.**

(c) Yes, Sir. PM SVANidhi Scheme has achieved its objective of facilitating loans to the Street Vendors to restart their business. As on 7th March, 2023, 42.09 lakh loans amounting to ₹5,046.5 Cr. have been disbursed under the Scheme through various lending institutions.
