(a) NABARD has disbursed funds under long term refinance and Long Term Rural Credit Fund (LTRCF) which permits dug well activities. State/UTs-wise details in this regard for the last three years and current year (till 31.12.2022) are given at **Annexure**.

Further, there is no refinance disbursement in Dadra and Nagar Haveli and Daman and Diu during the last three years and current financial year.
