- (a) the funds allocated and utilised for the projects under the PM Gati Shakti National Master Plan (NMP) that are being implemented by the Ministry, State/UT-wise;
- (b) the details of the projects proposed under the plan for multiconnectivity purposes, particularly in the State of Rajasthan;
- (c) whether the Gati Shakti platform has brought down the time and cost overrun of infrastructure projects since its launch; and
- (d) if so, the details thereof?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

(a) The Ministry is primarily responsible for development and maintenance of National Highways (NHs). All the NHs development projects of the Ministry are planned in line with PM GatiShakti National Master Plan (NMP) Principles.

No separate funds are allocated by the Ministry for PM GatiShakti NMP. State / Union Territory (UT) - wise details of funds allocated and expenditure incurred / funds released for development

of NHs during the last year and the current year are placed at Annexure-IA. Apart from this, year-wise details of funds allocated and expenditure incurred / funds released under other Schemes / Agencies for development of NHs during the last year and the current year are placed at Annexure-IB.

(b) Presently NHs Projects in a length of 3,315 km of NHs with a total capital cost of Rs. 45,786 Crores have been taken up in the State of Rajasthan.

In addition, a pipeline of projects in a length of 1,440 km has been prepared for award in the State of Rajasthan till FY 2024-25 at a total cost of about Rs. 17,042 Crores.

These projects are envisaged to provide the improved NH connectivity for 16 nos. of economic nodes identified under PM GatiShakti NMP in the State of Rajasthan.

(c) and (d) The Detailed Project Report (DPR) module tool developed by the Ministry through Bhaskaracharya National Institute for Space Applications and Geoinformatics (BISAG-N) along with the available features in the dynamic Geographic Information System (GIS) platform based PM Gati Shakti NMP Portal is helpful for optimizing the NHs project alignments and planning of projects considering information related to existing physical / geographical features, forest areas, eco-sensitive areas, etc., in minimizing ecological impacts, requirements of clearances and faster and more effective project preparation. This is expected to contribute significantly in faster implementation of projects by obviating need for mid-course corrections / revisions in project features during project implementation phases.
