Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether dealership of Petrol Pumps is not being awarded to the persons appointed by the public sector oil companies even after fulfilling the criteria due to lackadaisical attitude of the officials and if so, the reasons therefor;
- (b) the reasons for not giving approved IOCL dealership in Kalamb Taluka of Yavatmal district of Maharashtra; and
- (c) the details and the number of such cases during the last two years?

- (a) Public Sector Oil Marketing Companies (OMCs) award retail outlet dealership to the selected applicants meeting eligibility criteria and fulfilling the selection process laid down as per their Dealership Selection Guidelines, 2018. The selection is made based on online process of draw of lots/bidding amongst eligible applicants maintaining full transparency and minimum human interference.
- (b)&(c) Indian Oil Corporation Limited (IOCL) has informed that for retail outlets advertised in Kalamb Taluka of Yavatmal district of Maharashtra in November/December, 2018, applicants meeting eligibility criteria and fulfilling the selection process have been awarded Letter of Intent (LOI)/Allotment of retail outlet for 3 number of locations and in 2 number of locations the selection is not completed. Status of these selections are as below :-
