**MINI ANGANWADI CENTRES IN UTTAR PRADESH**

†2770. SHRIMATI KESHARI DEVI PATEL:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- a. the guidelines for setting up Mini Anganwadi Centres (MACs);
- b. the number of MACs currently operational in Uttar Pradesh indicating the facilities provided at the said centres;
- c. whether the Government has fixed any population criteria to set up MACs and increased the honorarium amount of Anganwadi Workers, if so, the details thereof;
- d. whether the Government has received proposals from Uttar Pradesh to set up more such MACs, if so, the details thereof and action taken thereon; and
- e. whether the Government proposes to upgrade such centres and allocate additional funds for construction of their permanent buildings or to increase the estimated cost and provide infrastructure and if so, the details thereof?

**ANSWER**

(a) The population norms for setting up of mini-Anganwadi Centres is tabulated as below:

	Population/ No. of Mini-AWC	
Rural/Urban Projects	150-400	1
Tribal/Riverine/Desert, Hilly and other difficult areas/Projects	150-300	1

(b) The Ministry of Women and Child Development has sanctioned 22290 Mini Anganwadi Centres to the Government of Uttar Pradesh out of which 22290 are operational. The facilities provided at Anganwadi Centres are as below:

- i. Supplementary Nutrition;
- ii. Pre-school Non-formal Education;
- iii. Nutrition & Health Education;
- iv. Immunization;
- v. Health Check-up; and
- vi. Referral Services has been provided to all eligible beneficiaries, namely, children in the age group of 0-6 years, pregnant women and lactating mothers through the platform of Anganwadi Centres across the country.

Three of the services viz. Immunization, Health Check-up and Referral Services are related to health and are provided through NHM & Public Health Infrastructure.

(c) As per the population norms for setting up of mini Anganwadi Centres:

From 1st October, 2018, Government of India has enhanced the honorarium of AWWs at main-AWCs from Rs.3,000/- to Rs.4,500/- per month; AWWs at mini- AWCs from Rs.2,250/- to Rs.3,500/- per month; AWHs from Rs.1,500/- to Rs.2,250/- per month; and introduced performance linked incentive of Rs.250/- per month to AWHs and Rs.500 to AWWs. In addition, States/UTs are also paying additional monetary incentives/honorarium to these functionaries from their own resources which vary from State to State.

(d) In the recent past, no proposal has been received from the Government of Uttar Pradesh for setting up of Mini Anganwadi Centres. Government has taken a policy decision to upgrade all mini AWCs to Main AWCs subject to States agreeing to bear their portion of cost. The proposal from UP in this regard is awaited.

(e) For upgradation of mini-anganwadi Centres to main Anganwadi Centres across the country, the Ministry of Women and Child Development has advised all the States/UTs having mini Anganwadi Centres to examine the actual need/demand of upgradation of mini Anganwadi Centres to main Anganwadi Centres taking into account the additional financial implication arising out of this upgradation.

Further, for upgradation of Anganwadi Centres (including mini Anganwadi Centres), following steps have been undertaken:

- i. Under Saksham Anganwadi, 2 lakh Anganwadi Centres (AWCs) (40,000 AWCs per year) across the country would be strengthened and upgraded for improved nutrition delivery and for early childhood care and education for children under 6 years of age. This year 40,000 AWCs have been identified in aspirational districts for upgradation. Saksham Anganwadis to have better infrastructure including internet/wifi connectivity, LED screens and smart learning and audio-visual aids and child-friendly learning equipment.
- ii. The cost of construction of toilet per AWC has been revised to Rs.36000/- from Rs.12000/- and the cost for providing drinking water facilities has been revised to Rs.17000/- from Rs.10000/-.
- iii. States/UTs have been advised to take up the matter of installation of rainwater harvesting in Government owned Anganwadi buildings.
- iv. A total of 50,000 AWCs (@10,000 AWCs per year) would be constructed under convergence with MGNREGS for a five year period ending FY 2025-26. The cost of construction of AWC buildings under convergence with MGNREGA has been revised to Rs.12.00 lakh per AWC of out of Rs.8.00 lakh would be provided under MGNREGS, Rs.2.00 lakh under 15<sup>th</sup> Finance Commission funds (any other untied funds) and Rs.2.00 lakh by MWCD per AWC to be shared between Centre and States/UTs in the prescribed cost sharing ratio.
- v. Grants are sanctioned for purchase of furniture, equipment, etc.
- vi. Anganwadi Workers (AWWs) have been provided with Smart Phones for efficient service delivery and Anganwadi Centres have been equipped with Growth Monitoring Devices.
