- (a) the number of Health and Wellness Centres operational under Ayushman Bharat Yojana, State/UTwise;
- (b) the total beneficiaries under the Ayushman Bharat Yojana, year-wise;
- (c) the total funds disbursed under the scheme in the last three years, year-wise;
- (d) the approximate number of citizens disadvantaged in some States due to non-implementation of this scheme by the State Government; and
- (e) the number of CHCs, PHCs, AB-HWCs and other empanelled hospitals and the number of Super Speciality Block proposed to be sanctioned and empanelled, State/UT-wise and district-wise in Himachal Pradesh?

(a) & (b): As on 28.02.2023 a total of 1,57,698 AB-HWCs have been operationalized across the country to deliver Comprehensive Primary Health Care (CPHC) that includes preventive, promotive, curative, palliative and rehabilitative services which are universal, free, and closer to the community. State/UT-wise details are at **Annexure-I**.

A total number of 85.63 crore footfall has been recorded on these AB-HWCs for the period 2019-20 to 2021-22. Year wise details are as follows:

(c) The financial assistance granted by the Government to State/UTs central releases under NHM during the last three years is attached at **Annexure-II**.

(d) & (e) National Health Mission (NHM) envisages achievement of universal access to equitable, affordable & quality health care services that are accountable and responsive to people's needs. The Ministry of Health and Family Welfare provides technical and financial support to the States/UTs to strengthen the public healthcare system, based on the proposals received in the form of Programme Implementation Plans (PIPs) under National Health Mission. Government of India provides approval for the proposals in the form of Record of Proceedings (RoPs) as per norms & available resources.
