Fertilizer subsidy for NBS rates

2850. SHRI D.M. KATHIR ANAND:

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether the Government has approved an additional fertilizer subsidy of Rs. 51,875 crore for the new nutrient based subsidy rates for phosphatic and potassic fertilizers for the Rabi season from 1st October, 2022 to 31st March, 2023 and if so, the details thereof;
- (b) whether the Government has allocated Rs. 60, 939 crore from 01.04.2022 to 30.09.2022 for the NBS scheme;
- (c) if so, the details thereof along with the details of the subsidy provided to farmers. State-wise:
- (d) whether 2.6 Lakh PoS devices have been deployed for the implementation of Direct Benefit Transfer (DBT) under fertilizers subsidy scheme in the country and if so, the details thereof, State-wise; and
- (e) the list of Lead Fertilizer Suppliers (LFSs) and the amount of funds allotted to them in the last two crop seasons?

- (a): Yes Sir, the Cabinet approved fertilizer subsidy of Rs. 51,875 crore under Nutrient Based Subsidy (NBS) scheme for Phosphatic and Potassic fertilizers for the Rabi season form 01.10.2022 to 31.3.2023.
- (b) & (c): Sir, the funds under NBS scheme has been allocated for the present Financial year as a whole i.e. for 01.4.2022 to 31.3.2023. The allocated budget is as under:

Further, the subsidy, under the NBS scheme, is given to registered P&K fertilizers manufacturers/importers which provide these fertilizers at subsidized price to farmers.
