AYURVEDIC MEDICINE MANUFACTURING COMPANIES

2913. SHRI JUAL ORAM:

Will the Minister of **AYUSH** be pleased to state:

- (a) the number of new companies manufacturing Ayurvedic medicines which have been established during the last one year;
- (b) the details of States in which these manufacturing units have come up; and
- (c) the number of people employed in the Ayurvedic medicines manufacturing units across the country?

ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) to (c) As prescribed in Drugs and Cosmetics Act 1940 and Rules 1945 made thereunder, enforcement of the legal provisions pertaining to Quality Control and issuance of drug license of Ayurveda, Siddha, Unani and Homoeopathy drugs, is vested with the State Drug Controllers/ State Licensing Authorities appointed by the concerned State/Union Territory Government.

As per the information received from State/UT government, the State/ UT wise details of new companies manufacturing Ayurvedic medicines which have been established during the last one year and the number of people employed in the Ayurvedic medicines manufacturing units across the country are as follows –
